Water Sample Report: HAA concentration is not an immediate concern. Council discussed discoloration in the water and instructed Clerk to obtain information on a water filtration system for next meeting.

Committee Reports:

Recreation Committee: Councilor Hierlihy reported a low turnout at the open house held last month. Upcoming activities include the sale of 50/50 tickets for St. Paddy's Day, community breakfast in April, cleanup day June 4th, Canada Day celebrations July 1st, and South River Day July 31st. The committee applied for a \$5000 heritage grant for Canada Day activities. The current bank balance is just over \$10,000.

Bay de Grave Regional Municipal Services Board: The bill from the Bay de Grave Municipal Service Board was discussed and the Clerk was instructed to gather details on the invoice.
